



Quick Reference Guide for Frequently Prescribed Medications

Medication Report



Med Report Forms are NOT required:

- For any SINGLE Class A Therapeutic Medication with < 24hr withdrawal.
- When a medication is administered well beyond the recommended withdrawal time.

Reports ARE required whenever:

- Multiple medications are administered.
- Withdrawal time is being calculated by the vet using the half-life factor.
- For Class B or C Strictly Controlled Medications. (Reference the Controlled Medication Database for Classification.)
- Anytime medications are administered outside of ESC guidelines.

Withdrawal: Recommended time that must pass between administering a SINGLE MEDICATION and time of competition.					
- Multiple medications given in combination may significantly extend the withdrawal time. Consult your vet for guidance if combining medications.					
Washout: Time it takes a medication to clear the system to prevent dangerous drug interactions or compounding effects. Consult your vet for guidance if switching medications.					
Type/Target Condition: Medication classification and/or symptoms the medication treats. Consult your vet for diagnosis and proper treatment.					
Conflicts: Medication combinations that are not allowed, may cause dangerous side effects, or that may extend the withdrawal time. Consult your vet for guidance.					
All medications used at an ESC sanctioned event must be prescribed by a licensed veterinarian.					
Only vets licensed in the state where the show is being held may treat, prescribe medications and file Medical Reports for horses during the course of an ESC horse show
